

#### The World Changed On November 17, 2019

- November 17, 2019 1st detectable case of COVID 19 in China
- January 20, 2020 1st US case: 35-year-old man in Snohomish, Washington
- January 30, 2020 WHO declares global public health emergency
- February 6, 2020 A person in California dies from the coronavirus 1st US death
- As of Friday February 5, 2021:
  - •26.3 M US Cases
  - •35.2 M Vaccines Administered (since February 4th)
  - •450,264 Deaths



- Dec 2020: PREP Amendment 4: Clarification on Training and Other Requirements for Pharmacist/Intern/Technician COVID and Childhood Vaccines
- Jan 2021: PREP Amendment 5: Permits Pharmacy License Reciprocity in Other States
  - Opportunity for Improvement: Pharmacists with expired license/certification authorized to administer the COVID vaccine




